FAMILY RESOURCE CENTERS OFFER BEFORE SCHOOL, AFTER SCHOOL AND FULL-DAY SUMMER PROGRAMMING THAT PROMOTES POSITIVE, HEALTHY DEVELOPMENT AMONG ADOLESCENTS AND TEENS; AS WELL AS YEAR-ROUND EVENING FAMILY ENRICHMENT ACTIVITIES THAT FOSTER FAMILY BONDING, CONTRIBUTING TO THE OVERALL WELLBEING OF THE FAMILY UNIT.
